## Director's Report Mrs. Fields

- The Self-Study of the LHS for the accreditation process will be submitted before March 1<sup>st</sup>. Once approved, the LHS will be given 12 possible names for a 2-person, 2-day onsite visitation, to be scheduled between July 15 and August 30<sup>th</sup>, 2017. The Board and some volunteers will take part in the meeting.
- The Director attended Advocacy Day in Washington, DC, meeting with aids of Senators Blumenthal and Murphy, Congresswoman Esty and other CT representatives. A presentation was made on the implications of budget cuts to the NEA, NEH and the IMLS.
- The Director will continue to send the Board emails of advocacy alerts.
- May 11<sup>th</sup>, at 6:30 PM the NEH- sponsored Community Round Table Meeting, "Growing Up in Litchfield," led by Rachel Carley, will be held at the Museum.
- June 3<sup>rd</sup> the "Digitization Day" will be held for the community to bring in items to be photographed for the museum's digital records.
- In the fall the LHS will do a community program on farms and farming in Litchfield.
- The LHS website is being updated technically to make it easier for staff to make changes and to be used on mobile devices.

- The State funds to catalog books held by the LHS a project for the last 5 or so years has been cut. LHS will move our library catalog to Bibliomation, a service used by many CT libraries including OWL. The funds to belong will now be covered by a small increase in the Technical Budget line.
- Plans to replace the lighting at the TR House with LED fixtures will cost \$18,000. The project will be funded by the Seherr-Thoss Foundation Maintenance Grant

- The Annual Meeting of the LHS will be held at the museum on Friday, April 21<sup>st</sup> at 5:00 PM, followed by the opening of the LFA Exhibit.
